

## COUNCIL 10136 MEETING MINUTES 2-12-2024

Meeting called to order at 7:34 pm by the Deputy Grand Knight.

Membership cards were not checked by Warden, however all present were identified as members in good standing.

Prayer was offered by the Deputy Grand Knight.

After Pledge of Allegiance, roll was waived. Previous meeting minutes were approved.

The Treasurers report was read into the record by the Deputy Grand Knight. The beginning balance was \$56,812.57. Credits were \$3,812.00 and disbursements were \$4,892.38 for a checking balance of \$55,732.19. The Fr John Fund totals \$49,539.98 for a total balance of \$105,272.17. There are \$1,040.43 in outstanding checks. The Tapped and Uncorked balance is \$2,100.00. We owe the Fr. John Fund \$5,778.00.

Our Chaplain gave us the Mass times for Ash Wednesday (February 14<sup>th</sup>). He also said that Stations of the Cross would resume every Friday during Lent.

The Recorder announced that the Mehlville Fire Department had its first baby put into its baby box. It is reported that the baby is doing quite well.

The Financial Secretary reported that he reached out to Renae Novak with the Archdiocese Vocations office. She expressed a need for support of two seminarians. We are assisting both of these seminarians on tuition to the tune of \$500 and \$400 per semester respectively.
