

COUNCIL 10136 MEETING MINUTES 05-12-2025

Meeting called to order at 7:35 pm by the Grand Knight.

Membership cards were not checked by Warden, however all present were identified as members in good standing.

Prayer was offered by the Grand Knight.

After Pledge of Allegiance, roll was waived. Previous meeting minutes were approved.

The Treasurers report was read into the record by the Treasurer. The beginning balance was \$79,044.00. Credits were \$19,440.40 and disbursements were \$12,786.21 for a checking balance of \$85,698.19. The Fr John Fund totals \$56,273.87 for a total balance of \$141,972.06. Outstanding checks total \$10,274.06. The Tapped and Uncorked balance is \$100.00. We owe the Fr. John Fund \$4,416.36.

The Chaplain asked us to rejoice in the new Pope and to pray for him and his call for unity.

The Recorder noted that he had received no correspondence.

The Financial Secretary had no report.

Membership had no report, however new members Rick Elder and Allen Hansen introduced themselves.

The Trustees had no report.

The Fish Fry chairman again thanked everyone who volunteered to make the Fry a success.

The Tapped and Uncorked chairman reported that planning meetings will start Monday. The event is scheduled, rain or shine, for Oct 4th.

The Pro-Life Director position is vacant and has not been filled.

The Chancellor explained particularly to our new members the tradition of 5th Sunday. He explained that when a month has 5 Sundays that we provide lectors, Eucharistic Ministers and Hospitality ministers. If available, we also provide an Honor Guard by our 4th Degree Honor Guard members. He reminded all members that our next 5th Sunday is June 29th. He further informed the new members, and reminded existing members, that the White House retreat for our council is scheduled for Sept 18th to the 21st. The Community Director reported that we need volunteers to move stuff from our current storage cage to the old Variety Guild cage which was made available when the Variety Guild disbanded.

The Sluggers reported that the wheelchair ramp and chair lift used by the late Al Nadolney, previously

installed by the Sluggers, was removed from his home.

The Field Agent talked extensively for 14 minutes about Knights of Columbus Insurance. He stated that they adhere to pro-life values in all of their investments but didn't have a definitive answer as to why they invested in US Treasury Notes and Bonds when HHS was sending 1.5 billion to Planned Parenthood.

The District Deputy stated that we have reached our quota of 12 new members needed for Star Council eligibility.
